The promotion will be subject to such terms and conditions as laid down in ESI Corporation (Staff & Conditions of Service) Regulations, 1959 as amended from time to time.

The promoted official may intimate her willingness or otherwise to accept promotion on regular basis within seven (7) days from the date of issue of this order failing which the promotion will be treated as cancelled.

The promoted official may exercise her option within one month from the date of regular promotion for fixation of pay.

The transfer of the official mentioned above is in public interest and is eligible for TA/DA and joining time as per rules.


The seniority of the promoted Official in the cadre of Nursing Sister will be determined in accordance with the order of the DPC recommendation.
