MINUTES OF PRE-BID MEETING HELD ON 09.04.2018 and 12.04.2018 AT 11.00 HRS IN R/O ANNUAL REPAIR AND MAINTENANCE OF ELECTRO MECHANICAL AND CIVIL WORKS TO ESIC HOSPITAL, PEENYA, BENGALURU

The minutes of pre-bid meeting held on 09/04/2018 and 12/04/2018 in presence of interested contractors is here by summarized for reference.

1. Clarification on deployment of extra persons: It was made clear that deployment of staff should be as per the tender document, no extra deployment will be entertained. Duty roster has to be prepared & submitted accordingly.
2. Bank Guarantee for EMD: Accepted
3. Exemption of EMD in r/o NSIC: It was clarified to M/s Veda Prakash Electricals that, bidders registered under NSIC shall be exempted from depositing EMD along with bid; subject to submission of supporting documentary proof.
4. National/General Holiday: O.T payable in respect of National/General Holidays as per Contract Labour Laws.
5. ESI, EPF & Bonus: It was clarified that ESI & EPF is applicable upto ceiling limit of Rs.21,000/- & Rs.15,000/- respectively. The Principal Employer is responsible for reimbursement of statutory payment.
7. Non tender items: Non tender items which are part of the work will be reimbursed with prior approval based on quotation.
8. Extra for providing & mixing water proofing material in cement plaster work: it was clarified that, it is per bag of 50kg.
9. Sl. No. 19.1 to 19.5: Since detailed B.O Q is not mentioned, this stand deleted and bidder may not quote for Sl. No. 19.1 to 19.5.
10. As per tender document GST is extra, it will not be included.
11. Part –B of Financial bid: Bills may be raised on completion of each item of work.
12. Participants were also informed that dates for technical bid opening and the last date for submission of bids would be postponed in view of enforcement of Model code of conduct for elections. Accordingly, it is informed that, following addition shall be taken into account:
