Ref:- Hqrs. office circular dated 27/6/2008 and 3/5/2018.

Sir/ Madam,

In reference to this office circulars referred above, it is clarified as under :


- 1) Pensioners who did not opt for ESIC-PMS-2006 at the time of retirement, can join the Scheme at any time after retirement by paying an admission fee of Rs. 30/-. However, as per instruction dated 27/6/2008, pensioners joining the Scheme after six months of retirement shall be entitled for super-speciality treatment only after a waiting period of six months from the date of joining the Scheme.
- 2) As per instruction dated 27/6/2008, a member of the Scheme shall have the option to opt out of the Scheme by a declaration upon which he will be eligible for revival of fixed medical allowance. The option shall be exercised only once and a pensioner who has opted out shall not be eligible to become member of the Scheme at any time later.

This issues with the approval of Director General. The instructions may be brought to the notice of all pensioners individually and the Pensioner's Associations of your region and may be uploaded in the website also.

Sub: ESIC Pensioners medical scheme, 2006- Removal of difficulties

A copy of Headquarters Office Letter No. D-12/16/1/2017-E-VI-Vol.I dated 05/10/18 on the above cited subject is enclosed herewith for information of all concerned.

The clarification regarding joining of PMS is mentioned below for reference.

1. Pensioners who did not opt for ESIC-PMS-2006 at the time of retirement, can join the scheme at any any time after retirement by paying an admission fee of Rs. 30/-.
2. Pensioners joining the scheme after 6 months of retirement shall be entitled for super-speciality treatment only after a waiting period of 6 months from the date of joining the scheme.
3. A PMS member shall have the option to opt out of the scheme by a declaration upon which he will be eligible for revival of Fixed Medical Allowance.
4. PMS members once opted out of the scheme, shall not be eligible to become member of PMS at any time later.
